## **Final Restorative Practices Workshops for School Staff**

## **“Tea” That Has Opioid Like Action**

- Poison control centers are getting a surge of calls about ‘natural’ painkiller kratom.
- [STAT News](#) reports poison control centers are getting more calls about problems stemming from people ingesting kratom, an Asian plant that can be used to make tea, according to a new report from the Centers for Disease Control and Prevention. Kratom can cause side effects such as “nausea, vomiting, drowsiness, and agitation,” but when combined with other substances it can cause more serious side effects. The article reports that kratom can also be highly addictive and that it stimulates some of the same brain receptors that opioid drugs do.

## **CURRENT GRANT OPPORTUNITIES**

### **NEW EARSS Restorative Practices Grant**

- The [Colorado Department of Education](#) has announced the EARSS Restorative Practices Grant for the period of January 2017- June 2018.
- The Expelled and At-Risk Student Services Grant (EARSS) Restorative Practices Grant is a one time, 18-month program to encourage the use of school-based restorative practices within Colorado as a standard response, as appropriate, to student misconduct. The grant encompasses both a required planning process and the implementation of the resulting plan.
- Applicants must apply in one of the following two categories:
  - Begin to implement formal restorative practices; or
  - Expand beyond the early implementation of formal restorative practices.
- These implementation and expansion categories are described in more detail in the Request for Proposals.
- Approximately \$1.2 million is available for the EARSS Restorative Practices Grant. Applicants may apply for up to \$118,000 to cover a January 2017-June 2018 award period. It is anticipated that at least 10 grants will be awarded.

Funds for the 2015-16 state fiscal year are allocated to TGYS from the tobacco Master Settlement Agreement, the State of Colorado General Fund, and the Marijuana Tax Cash Fund.

## **Safe Routes to School – Funding Opportunity**

- The [Colorado Department of Transportation](#) (CDOT) announces their Fiscal Year 2016-17 Safe Routes to School (SRTS) Infrastructure and Non-Infrastructure Projects grant applications for project funding.
- The goal of SRTS is to help schools, school districts and local communities enable and encourage more children in Kindergarten through 8<sup>th</sup> grade to safely bicycle and walk to and from school. Eligible activities include, but are not limited to:
  - Planning, design, and construction of safe school routes for children to walk and bike to and from school
  - Planning, design, and construction of facilities for pedestrians and bicyclists to travel to and from school
  - Educating children, parents, and communities about safe walking and bicycling practices and the health benefits that result from walking and bicycling to and from school


